Leaving the midseason tournament prior to the completion of scheduled matches may be cause for a grievance to be filed by the State League Coordinator against the captain and the team. The Grievance Committee may impose penalties and fines up to \$ 50.00 per player and the players will be unable to participate in any USTA league until the fine is paid.**

**Any team withdrawing from the tournament after the draw is made for the midseason tournament may be subject to a grievance filed by the State League Coordinator and the same penalties may be imposed by the Grievance Committee.**
